Community Outreach Programs:
Building upon the foundation of animal rescue and adoption, Joybound reaches out to our community to provide a wide breadth of services to support pet families.

Our Shelter to Service program trains carefully selected shelter animals to become psychiatric service dogs and emotion support animals, assisting veterans and other individuals coping with psychological trauma and mental health challenges. This year, 131 people were enriched by psychiatric service dogs, facility dogs, and emotional support animals.

Joybound's Pet Safety Net program provided counseling, financial support, and resource referrals to help 1,100 families retain their

Animal Care & Adoptions:

This year, Joybound People & Pets placed 2,041 cats and dogs into new, loving homes through its adoption program. Each animal was behaviorally and medically assessed, treated as needed, spayed or neutered, and microchipped prior to adoption. While awaiting placement, all animals received daily enrichment, compassionate care, and basic training to enhance adoptability and promote well-being. In addition to routine shelter operations, Joybound also provided emergency rescue relief by assisting animal organizations impacted by natural disasters. We transferred animals in need from areas affected by events like wildfires, provided urgent veterinary care and housing, and facilitated adoption placement. These collaborative efforts helped ease the burden

Veterinary Clinic:

Joybound's onsite veterinary clinic provides essential medical care and surgical procedures for animals in our adoption program. Additionally, through our public spay/neuter initiatives, we support community members and rescue partners in addressing companion animal overpopulation. A total of 4,888 spay and neuter surgeries were performed during the year for both shelter and public animals, helping to reduce shelter intakes and prevent unwanted litters. Another 283 quality-of-life surgeries were performed to enable dogs and cats to live their best lives possible. Additionally, 1,049 veterans received free veterinary wellness exams, vaccinations, and preventative treatments from Joybound's caring Clinic team.

 urgent challenges in FY 2024-2025, including rising shelter
 populations, veterinary shortages, and growing economic barriers faced
 by pet families. We increased the number of training classes offered as
 well as offered individual behavior specialty consultations. We
 continued to grow our Shelter to Service program, supporting veterans
 with service dogs trained through Joybound's structured model, while
 expanding the program to be available to other individuals experiencing
 mental health challenges.

Our FoodShare pantry program provided food and supplies to pets in
 need. The Community Veterinary Care program provided needed veterinary
 care to pet families experiencing financial hurdles. Meanwhile, the Pet
 Hug Pack brought moments of connection and healing to the most
 vulnerable members of our community.

We also advanced workforce development through our Grooming Academy,
 which provided hands-on training for individuals facing employment
 barriers and delivered affordable grooming services to the public and
 shelter animals - enhancing both adoptability and community pet care.
 Through each of these initiatives, Joybound continues to fulfill its
 mission: strengthening the bond between people and pets and helping
 them thrive-side by side.

 pets during times of crisis. The Community Solutions team responded to
 2,137 calls and emails, offering expert guidance to community members
 facing animal-related challenges.

Joybound hosted monthly free Vaccine and Microchip Clinics to provide
 essential preventive care for pets in underserved communities - serving
 2,938 cats and dogs during the year. These clinics were offered on the
 Joybound campus and at partner locations across Contra Costa County and
 help protect public health by delivering core vaccinations and by
 ensuring pets can be identified and reunited with their families
 through microchipping. By removing financial and logistical barriers,
 the program supports pet retention, helps keep pets healthy, and
 reduces shelter surrenders.

Through the Community Veterinary Care fund (CVC) 442 veterinary exams
 were provided to pets from low-income households in Contra Costa
 County, ensuring these animals received critical veterinary care.

Our Pet Food Pantry program provided 30,840 meals to ensure that cats
 and dogs did not go hungry. For grieving pet owners, Joybound held
 monthly Pet Loss Support Group meetings, providing support and care
 during a very difficult time to 43 people working through the loss of
 their pet.

Joybound's Pet Hug Pack therapy animal program continued to provide
 emotional support and companionship to individuals in hospitals,
 schools, care facilities, and community outreach events. This year, Pet

Animal Behavior and Training:

Joybound provided a robust schedule of in-person training classes aimed at promoting positive pet behavior and strengthening the human-animal bond. This included 939 classes teaching basic manners, puppy social skills, kitten kindergarten and other group training sessions. Private consultations provided 1,450 dog and cat guardians with customized support either in person, virtually or by phone.

Grooming Academy:

Joybound's Grooming Academy was launched in June 2024 to address workforce barriers while supporting community pet wellness. The academy provides hands-on training in professional grooming for individuals facing employment challenges, including veterans and others with limited access to job opportunities. Graduates are equipped with marketable skills for careers in the pet care industry. At the same time, the program offers affordable grooming services to the public and to Joybound's shelter animals, improving adoptability and overall animal wellbeing. During the year, 46 students completed the Grooming Academy, and 1,510 public and shelter dogs were groomed with care.

Service Volunteers:

During the year, 779 active volunteers shared 56,918 hours of their time across Joybound's full breadth of programs - from fostering, to greeting visitors, to assisting with laundry, to walking dogs, to socializing cats.. you name it. Joybound could not accomplish all that we do without these selfless volunteers.
